Question (a): whether the Government has approved the proposal for expansion of Muthalapozhy Fishing Harbour in Kerala and If so, the details thereof;

Reply: Yes. The Government of India has accorded the administrative approval for expansion of Muthalapozhy fishing harbour proposal amounting to Rs. 177 crores under the Centrally Sponsored Scheme Component of Pradhan Mantri Matsya Sampada Yojana (PMMSY) vide letter No. j-24001/53/2024-Fy (E-24965) dated 01st November 2024.

Question (b): the details of measures proposed for ensuring safety in the harbour to prevent recurring accidents and causalities:

Reply: In order to ensure safety and safe manoeuvrability in the harbour, the following safety measures have been included in the expansion proposal;

1. Extension of Southern breakwater for an additional length of 425 m to a depth of -10.5 m contour and a Northward opening for the entrance channel.
2. Dredging of the navigation channel to -5.0 m.

Question (c): the time by which the expansion works will be started

Reply: Information not available in the Institute.

Question (d): whether the Government has set any deadline for the implementation of approved expansion plan; and

Reply: Yes.

Question (e): If so, the time by which the details thereof;

Reply:

As per the administrative approval, the Government of Kerala has to ensure the completion of the project within a period of 18 months. The Government of India will count the project completion period after two months from the date of issue of administrative approval.
